Validity Prices are valid for thirty (30) days from the quotation date or the closing date of the attached RFQ.

Pricing All unit prices are based upon the quantities indicated. We reserve the right to adjust our prices accordingly, should the official order vary

from the quoted quantities.

Technical Specifications are as per the literature attached. Our Product Managers and Application Specialists are available, should you require any

additional information on the products quoted.

Warranty Our standard warranty of one year covers defective parts and labour. All brand specific extended warranties cover defective parts only.

Extended warranties shall not apply to any equipment which has not been maintained and/or serviced in accordance with the manufacturer's recommendations, by their approved service agents. Damage caused by unstable power supply is not covered by the warranty. An uninterrupted power supply with surge protection is recommended for sensitive instruments.

All warranties exclude travel and/or freight to and from Lasec service units.

Repairs Evaluation of all items, either undertaken in-house or on-site, is subject to a minimum charge. This fee covers the inspection of the item

and determination of the cost to repair the faults identified. In the case of non-warranty repairs or maintenance where a revised estimate is required, an updated quotation will be provided for approval. Should the revised quotation not be accepted, the client will be liable for all charges incurred to date. Should no fault be found on items submitted for repair, the client will be liable for any costs incurred during

evaluation, regardless of warranty status.

Payment terms Thirty (30) days nett from date of statement. A deposit of a minimum of fifty percent (50%) is required upon order confirmation for Account Holders specially ordered items with the balance payable thirty (30) days from date of invoice, otherwise by arrangement.
